## CALL MEETING TO ORDER

Chairman Josh Sorensen called the meeting to order at 7:00 p.m. Other board members present were Carol Hepworth, Larin Mortimer, Lon Harrington, and Toni Ibarra. Also attending were Superintendent Mark Kress and Board Clerk Terisa Coombs.

#### 2. PRAYER/PLEDGE OF ALLEGIANCE

Larin Mortimer opened the meeting with a prayer.

#### **ACTION ITEMS**

#### a. Approval of Agenda

A motion was made by Carol Hepworth and seconded by Lon Harrington to approve the agenda as presented. All board members voted aye. Motion passed 5-0.

c. High School Class Fee Hearing

Snake River High School is proposing to increase class fees because of the increased cost of materials for the 2023-2024 school year for the following classes: 3D printing, Ag 130, 210, 211, 240; FCCLA; Nutrition and Foods; Intro to Hospitality and Tourism; Hospitality Services; and Elite Men's and Women's Choir. The Notice of Fee Increase was posted in the Idaho State Journal on April 7 and 14, 2023. Discussion was held.

Lon Harrington moved and Carol Hepworth seconded to approve the Snake River High School Class fee increases as presented. All board members voted aye. Motion passed 5-0.

d. <u>Supplemental Levy Canvass</u>
On March 21, 2023, the county election office presented the official canvass of the district's Supplemental Levy Election held March 14, 2023, to the Bingham County Commissioners (who act as a Board of Canvassers of Election). The commissioners approved the canvass as presented. There was about 10% of voter turnout. After discussion, the board feels that this was because of the threat of flooding in the area and it was a poor weather day. The board publically thanked the community for their support of education in our area.

Lon Harrington moved to accept the official Bingham County Commissioners' canvass of March 21, 2023 regarding the district's Supplemental Levy Election held March 14, 2023. Carol Hepworth seconded. All board members voted aye. Motion passed 5-0.

#### e. Summer Football Equipment Authorization

According to IHSAA rule, the board must send a letter to the IHSAA asking for written permission for the coaching staff to use the school's protective equipment for summer football camps. The Varsity/JV/Freshmen teams will participate in a summer football camp July 12-21, 2023.

A motion was made by Larin Mortimer and seconded by Lon Harrington to approve a request that the IHSAA give written permission for the coaching staff to use the Snake River High School's protective football equipment for the football team summer camp on July 12-21, 2023. All board members voted aye. Motion passed 5-0.

## a. Superintendent Report

## 1. School Safety Report:

A lengthy discussion was held about safety in the district. The district is committed to making schools safer. There have been great strides made at Moreland Elementary. A new entry system is currently being installed and by next year, it will be fully functional. Also, the district has two school resource officers. Superintendent Kress is working on a grant to help fund security projects. Night locks are being installed in different schools and it will be finished up during summer.

More security cameras and door alarms will be installed this summer. School lockdowns and shelters in place were discussed. Other options were discussed including First Shot Detection, additional school resource officers, training, etc.
