a. Approval of Agenda

c. Jr. High Class Fee Hearing

Snake River Jr. High is proposing to increase class fees because of the increased cost of materials for the 2024-2025 school year for the following class: Young Living from \$20.00 to \$30.00. The Notice of Fee Increase was posted in the Idaho State Journal on April 12 and April 15, 2024.

Lon Harrington moved and Carol Hepworth seconded to approve the Snake River Jr. High class fee increase as presented. All board members voted aye. Motion passed 5-0.

d. Breakfast/Lunch Fee Increase Hearing

Snake River School District #52 is proposing to increase school lunch and breakfast program fees for the 2024-2025 school year. This increase in fees is to comply with the USDA required fee increase. This is to cover the cost of food, supplies and employees. The Notice of Fee Increase was posted in the Idaho State Journal on April 12 and April 15, 2024. Discussion was held about the difference between what the district charges for meals compared to what the USDA recommends the district should charge. Rene Osman, Child Nutrition Director will send the board the USDA recommended prices.

A motion was made by Lon Harrington and seconded by Carol to approve the Snake River School District Lunch and Breakfast fee increases as presented. All board members voted aye. Motion passed 5-0.

e. Summer Football Equipment Authorization

According to IHSAA rule, the board must send a letter to the IHSAA asking for written permission for the coaching staff to use the school's protective equipment for summer football camps. The request will have a statement of recognition that IHSAA sponsored catastrophic insurance provides no coverage for the activity and any liabilities rest solely with the school or camp. The Varsity/JV/Freshmen teams will participate in a summer football camp July 15-18, 2024.

Carol Hepworth moved and Lon Harrington seconded to approve a request that the IHSAA give written permission for the coaching staff to use the Snake River High School's protective football equipment for the football team summer camp on July 15-18, 2024. All board members voted aye. Motion passed 5-0.

f. Reschedule May Board Meeting

With May being a busy month and negotiations beginning hopefully the first week in May, moving the board meeting to Monday, May 20th would give everyone more time to prepare the documents for the board meeting. Discussion was held.

A motion was made by Larin Mortimer and seconded by Lon Harrington to reschedule board meeting from May 15, 2024 to May 20, 2024 at 7 p.m. at the Snake River Community Library at 7 p.m. All board members voted aye. Motion passed 5-0.
